a) Metro Regional Transportation Project Update

Staff has been asked to provide RTAC (Regional Toll Advisory Committee) a list of projects that will be impacted by tolling.

b) I-205 Tolling Update

Council is considering doing a poll to reflect the residents view on tolling to counter ODOT's survey. Councilor Baumbgardner shared that ODOT's pause on tolling ODOT has taken away the third lane on the widening project.

The upper area past Greene St will have a RRFP crosswalk to Barrington Dr. Staff has created a GIS map showing the sidewalks in the City of West Linn for the TAB to review to revisit a previous conversation regarding sidewalks.
