REASON REQUESTED DAILY AFTERNOON RUSH HOUR TRAFFIC BOTTLENECKS ON HWY 43. FOLKS ARE IN SUCH  
A HURRY, THEY BYPASS PART OF THE CONGESTION BY DIVERTING UP ARBOR, DOWN UPPER MIDHILL AND  
THEN DOWN MARYLHURST TO THE LIGHT AT HWY 43. MULTIPLE VEHICLES ARE DRIVING IN EXCESS OF  
DOUBLE THE SPEED LIMIT. FOLKS ARE WALKING THEIR KIDS IN STROLLERS, THEIR DOGS AND KIDS ON BIKES

ADDITIONAL COMMENTS: THIS ISSUE HAS ALWAYS BEEN SINCE I MOVED HERE ALMOST 30 YEARS AGO.  
SINCE THE WATER MAIN REPLACEMENT AND REPAVING, THE ROAD SURFACE IS SMOOTHER. THIS SEEMS  
TO HAVE CAUSED EVEN MORE TRAFFIC TO TRANSITION THRU AT MUCH FASTER SPEEDS.
