Minutes July 12th, 2016

Meeting of the Robinwood Neighborhood Association(RNA) called to order at 7:07pm.

Agenda approved. **Introductions:** Scott Bay from Old River Road.

June 2016 Minutes approved by voice vote, motion by Mary Hill, second by Peter Lang.

Treasurer Report: Kevin Bryck - Previous 2015 city grant was \$1366.20. The 2016 grant was reduced to \$952.24, a 30% reduction, so that the numerous small inactive NAs up on the hill could receive more money. Deposit on 7/06 resulting in a new balance of \$2294.46 with a pending debit of \$23.98 to renew the RNA domain for 2 years.

Guest Speaker:

Lance Calvert, Public Works Director, regarding HWY 43 / Hidden Springs intersection re-design update. Latest drawings available on city website(see below). Presentation at Council/PC joint work session on Monday 7/18. Lance will meet citizens by arrangement. New data includes accident data and projections. Intersection plan derived from meetings with consultant Kittelson & Associates and ODOT prior to any public input or comment.

Primary goal is accident reduction and secondary goal is traffic flow. Commercial and private driveway access not yet addressed. Effects on intersection of Cedaroak and Old River not studied or addressed. Numerous objections to the plan were raised. Links here:
