Old Business

- Hwy 43 update
Update from Lance Calvert - ODOT is currently working with the project consulting engineer on preliminary design and survey. Survey is mostly complete, and design is underway along with review of other project details like drainage, etc. Due to the nature of federal aid projects, meeting the project budget is becoming increasingly difficult so the consultant is working on finding ways to reduce overall cost associated with construction prior to final design. Hopefully, beginning of next calendar year we will have something to present to Council and the public. ODOT is targeting 2021 for construction.

In the meantime, the city has hired a consultant to design the replacement of the dilapidated water line along Highway 43. We anticipate the water line work being done in summer of 2020.

- Neighborhood plan update
We have updated the neighborhood map to show pathways today, Proposed Safe Route to School – for Cedaroak School, current concrete sidewalks, and what we call commercial and Transitions.

We are also drafting some changes to the Robinwood Neighborhood Plan specifically addressing alternative pathways and what the neighborhoods desire, specifically to be involved in planning up front when it comes to sidewalks and pathways.

New Business

- Ryan P. home owner on Walling Circle. Shared his concerns and those of his neighbors that his remodel is triggering a half-street improvement. Working on a Fee In-lieu, but not much hope. RNA Board said they would reach out to a few folks at the City and see what options are available.
- Bobbi D. raised concerns about an unsafe and unmarked pedestrian crossing at Hidden Springs and Wilderness Drive. Would like to see some type of signage/ markings
