Treasurer's Report: No expenditures, current balance is \$3594.80

Chief Mahuna: Homeless on private property removed immediately. Public property is stickier depending on jurisdiction, such as ODOT or MSYoung being state property, requires getting state agreement. With recent court changes WLPD can now enforce. Focus is getting people help with services rather than simply moving them to next site, therefore it could take a couple days. Where do we send them? Citizens call non-emergency and report. What is driving people who are service resistant? New Behavioral Health staff to do this.

Luke Borland - Public Works Update: Upper Midhill water line project main is in and tested, paving done with one tie-in this week. Landscaping and restoration in next weeks. 4700 feet of new line replacement ductile iron. Road program on Upper Midhill and surrounding cul-d-sacs to start in March. Hidden Springs from Santa Anita to Wilderness starting this fall and resuming in the spring. Cedaroak swale maintenance to replace dead trees with contractor still responsible. Calaroge Pump Station currently working through control issues with plantings to be maintained by contractor. New operations building off Salamo still in design phase. Construction to start summer of 2026 with 15 month construction time.

David Dodds volunteered to restart Parks Committee.

Conditional Use Permit Committee to address Kaady Carwash application by Shane Winder

Last week application deemed not complete due to lack of ground floor windows; Kaady has until February 25th but should not take that long. Another committee meeting not yet scheduled watch your email. Kaady has strategy to open 2 locations and then close one. Purchase usually based upon Planning approval.

Community Development: To operate as intended to assist in Planning. Requested hard copies of docs to review. Next meeting 9/23 6:30pm at Station. Do we want to again try to get city to adopt the Neighborhood Plan changes from 2017?
