Meeting of the Robinwood Neighborhood Association(RNA) called to order at 7:05 pm. August 2014 Minutes approved by voice vote, Motion by Mary Hill, second by Duane Funk. Treasurer Report: Balance on 9/09 is \$899.59 with \$434.23 picnic expenses and \$43.29 for Outreach flyers. There is a previously authorized balance due FORS for half of Outreach magnets, less RNA payment for flyers.

Planning Upper Midhill Development - Joanne Desky spoke for group of neighbors regarding Pre-App proposing 34 homes. Concerns: not compatible with adjacent lot sizes, traffic of 300-400 additional trips per day based on 1999 study, construction impact, drainage, possible historic landfill, potential wetland. Is this the right fit? Does benefit outweigh impact? Next city step: hearing regarding vacation of Upper Midhill right-of-way.
