Call to Order:

Treasurer's report:

- \$308.73 distribution from city added to account, bank account sent around to members. Major told us that 10k gets set aside for NA and 1k gets set aside incase a NA needs extra \$\$. Bi-laws show what the funds are used for. Major said that it would be nice if the money would be used in the community then sit in a bank. We can talk to city to see where the community needs it. Our total is \$7540.71.

General Obligation bond:

.42 cents on the dollar on assessed value of the home goes to the bond. Want to renew the bond so city can keep up projects. Would not increase taxes. Variety of potential capital projects is what it would be used for. City did lots of surveys in the community on the bond. The survey showed that transportation is the biggest concern. Including cross walks, lights & pedestrian areas. Library needs roof, old city hall, community centers & fire departments needs work and/or upgrades. Still working on project list but the projects needs to be stated in the next 3 years and completed within 5 years City of really becoming very constrained and will not be able to do several of these projects if bond is not passed.

Cities goal is for every home to be within walking distance of a park. Issue with West Linn is several of major roads in the city are not maintained by the city but maintained by the state. State will take care of inside of the road and city will take care of curbs and bike lanes. Pimlico & 43 will get a light in 2nd phase. Go bond has several upgrades to streets including Rosemont & Salamo. City was in talk with tri-met about better bus routes. Tri-met has no plans so city is checking on different models of inter-city transportation. Last mile issues for people getting to bus stops. National program being looked at by the city. Town hall in April will be focused on the go bond. Trolley lane-long term plan to be used as a pedestrian/bike lane by 2025 goal. Old business:

- Neighborhood beautification project- Dave met with parks and rec to identify parks, so we can get a game plan. Start at front of park and work around playground. We need to do this quarterly.
- Adopt a street- Picking up litter, we table this for now until we get bigger and put our efforts into park.

- Locating and designing street signs for the Neighborhood Association- NA wants to make a logo, Abby made motion for residents of West Linn to design. This was passed by all members. We would give a small prize for the winning logo.
- Pedestrian safety improvements on Pimlico Dr. & Summit St.- Not sure when this will be done but the city was out and did measurements.

Community Comments:

- Summit & Horton would like a 3 way stop. Put in a traffic safety committee request.
- City university in April- volunteers that work at Mary S Young. Julie will work on post card for a neighborhood association picnic that will be held on April 21st at Sahallie Illahee Park.
