MEETING MINUTES

Thursday, June 6, 2019

1.Call to Order

Abby Farber called the meeting to order at 7 p.m.

2. Review of Agenda

The agenda was approved.

3. Approval of Minutes

The minutes of the meeting on May 2nd were approved.

4. New Business

- The first visitor was Judy Wiechmann of the West Linn Public Safety Advisory Board. Judy spoke to the group about Map Your Neighborhood. In a disaster, the most immediate source of help is neighbors living around you. The program is designed to teach neighbors to rely on each other through the first hours or days of a disaster before fire, police, medical or utility workers arrive. It is designed to improve disaster readiness at the neighborhood level. Group leaders will invite their neighbors to a neighborhood meeting where they will learn the 9 steps to take immediately after a disaster. These steps include turning off gas and water connections.
- The second visitor was Christine Kennedy of West Linn-Lake Oswego Village ("WLLO"). WLLO is a non-profit organization that directs community efforts to allow people to remain living in their homes as they age. WLLO village includes the communities of Lake Oswego, West Linn, and the Stafford Hamlet. While WLLO is an all-volunteer organization, there are costs associated with building and maintaining the community. WLLO needs to pay for required certifications, computer programs, printing, telephones, etc. Therefore, memberships come with a fee. Still, WLLO is working to keep memberships affordable and charge \$2 a day or less. The type of services included in a full membership include help at home, occasional housekeeping, occasional pet care, paperwork management, help with technology, light maintenance, occasional light yard/garden work, companionship visits, check in phone calls and transportation to medical appointments, other appointments.
- The Neighborhood Association approved an expenditure of \$100 to join with other Neighborhood Associations in recognizing first responders at the Old Time Fair in July.

- Interest was expressed in being kept informed about the I-205 Project.
- The association voted to hold an association picnic on Sunday, July 28th from 1 pm to 3 pm. It will be a potluck with the association providing soft drinks and chips.

5. Old Business

- The review of the by-laws was tabled until the July 11th meeting.
- The resolution adopted at the May 2nd meeting was sent to the WL City Council and the WL Planning Commission.
- Regarding Sahallie Ilhahee Park, no date has yet been set for installation of the playground equipment at the park.
- Clean-up dates for Sahallie Ilhahee Park were scheduled for June 29 and August 24th.

6. Announcements from the Community and the City

- Three members attending the meeting had attended a recent open house on the West Linn Waterfront Redevelopment project. It was noted that another open house would be held on June 20th.
- An open house on Streetscapes Improvement will be held at the West Linn Police
 Department on June 13th which will discuss Willamette Falls Drive in the Willamette
 Neighborhood and the intersection of Salamo Road and 10th Street near the I-205
 intersection.
