DRAFT MEETING MINUTES

September 5, 2019

1. Call to Order 7:00 PM

Abby called the meeting to order at 7 pm.

2. Review, approve Agenda

The agenda was approved.

3. Approval of Minutes

The minutes of the August meeting were approved.

4. Old Business

- a. The August 24th cleanup at Shallie Ilhahee Park was attended by 9 adults and 7 children. The cleanup was reported in the weekly update circulated by the city of West Linn.
- b. Susan and Bill updated the members of the N.A. on the Wilderness Park Cleanup which is scheduled for September 28th. SOLVE gave the effort a grant of \$100 to buy materials and tools for the cleanup. Eight people have already signed up to participate in the cleanup and they are looking for additional volunteers. This includes talking with Nature Conservancy and with the West Linn High School Environmental teachers.
- c. John Walker led a discussion of neighborhood signs. John showed picture of the signs current used in the Willamette N.A. and the Savanah Oaks N.A. John also outlined potential locations for the signs including (1) Pimlico at Summit, (2) Skyline at the Reservoir, (3) Horton at Santa Anita, (4) Salamo at Rosemont, (5) Shannon Lane at Rosemont. There was a discussion of the logo that would go on the design. This led to a discussion about a potential contest among high school students who were residents of West Linn for an appropriate logo. It was suggested that a prize of \$100 might be offered. No progress has been made on RSNA business cards.
- d. No progress was made on the RSNA Business Cards.

5. New Business.

a. The next cleanup will be scheduled for a date to be determined in October. This is because all the weekends in September had already been scheduled for cleanups in other areas. There was a discussion of formulating a vision for Shallie Ilhahee Park so that progress could be made do to

lack of maintenance on the site. Collaboration and discussion with West Linn Parks and Recreation might help in formulating a vision. Further there was discussion of the possible purchase of a brush hog to help remove some of the invasive species in the property. The discussion expanded to potential cooperation with other N.A.

b. Discussed were various methods to increase participation in the N.A. including a neighborhood survey to determine the interest and priorities of the residents of Rosemont Summit. One potential survey tool is Survey Monkey. Discussion focused on the optimal method of distributing a survey to Rosemont Summit residents. This could include the use of Next Door.

6. Announcements from the Community and the City

David Baker indicated that the November ballot would include a vote on a bond for the West Linn Wilsonville School District. This resulted in a discussion that members of the N.A. might be interested in a presentation at the October meeting about the measures covered by the vote. If a speaker can be procured, the presentation by City Manager Eileen Stein may be postponed under the November Meeting.

David also suggest that it might be useful to invite Rachel Prusak to discuss the recently enacted legislation that could affect the single-family home nature of West Linn.
