We continue to seek ways of reaching the citizens of West Linn and to encourage them to contact their Federal Congressional delegation concerning the closing of our post office.

Our major tool of influencing this decision is your voice. If you have not called the members of our Congressional Delegation I ask that you do that now. As a matter of fact, it can help for you to call a second time to place emphasis on your concern surrounding this decision.

Call our Senators and Representative and leave a simple message. Give your name (spell it out), your location/West Linn/97068,

you are asking the Senator/Congressman to help keep the permanent local full Postal Service in West Linn.

The message can be that simple. Polite and courteous language leaves a positive impression.

C. Street Crossings on Rosemont Road -

At our January meeting, we passed a resolution to request Pedestrian Crossing Signs at crosswalks along Rosemont Road and Meadowlark Drive and Wild Rose Drive. Abby has sent the request to the City (Street Department and CC'd to other officials) and will have an answer shortly (probably in time to update this agenda item!) We also discussed getting the Parker Crest NA to support this as well. Abby has emailed that NA.

D. Restroom facilities at Wilderness, Sahallie Illahee Park

Abby has contacted the Parks department and started discussion on this issue. Composting to ilets are in use throughout the world, and several manufacturers have updated the technology to keep them odor-free and low maintenance. We'll continue doing research on this issue.

E. Communications Tower and Kapteyns Property

The City Council will be holding a hearing on February 8 re the City's proposed annexation of the property. Annexation will ensure that any future development on this property will be regulated by West Linn's Community Development Code.
