February draft minutes were read by Kathie Halicki. Julia made the motion to accept the minutes with the correction of Lance is with Public Works and not with Planning Dept. Elizabeth seconded and the minutes passed unanimously.

March draft minutes were read by Elizabeth Rocchia. Marty made the motion to accept the minutes with the correction of 'West Linn for Inclusion' is in reality called 'West Linn for Inclusive Community'. Julia seconded and the minutes passed unanimously.

ODOT Stacy Thomas

ODOT installing cable median barriers. State wide mandate. This will be going on through the 4th of July. As of the 4th of July paving on 205 from I-5 to the Abernathy Bridge is to start. All work will take place at night. Overlay = asphalt over concrete.

Huge priority is adding 4th lane to each side of 205. Fast tracked construction for 2019 or 2020. Up-grade seismically to bridge. Some of the ramps to be completely redone. Funding for design is allocated, not for actual work. Reconfiguring on and off ramps at Hwy. 43. There will be some blasting to remove some of the basalt on the ramps to and from 43. Sound/noise studies are to be done.

Land Use 1754 WFD = 2 story office 6,000 sq. ft. building.

Steve Sutherland 1742 Willamette Falls Drive (property owner, Ameriprize Office) doesn't like this office building.

- a). code references to congruent size.
- b). Trees. 3 trees, 2 of which are significant, anything over 10" diameter is considered significant, (cedar). Taking them all out. Fir tree on Steve's property line? Doesn't want to see trees go. No one ever talked to property owner about removing trees even though it was stated in public record that 1745 WFD got permission from both sides of property. False.
- c). parking issue. 16 parking spaces. City says no need for parking. This will set a precedence. Perhaps a smaller scale building would mean less parking.
- d). Tues. April 18th Historic Review Board and Wed. April 19th Planning Commission meeting.

Jenny Haddow = owner of 1754 owns a CPA practice. Wants to move to WL due to children's needs. New owners of this property. Would have liked to convert a house into

business. Historic Review Board said this building must be built this way. Wanted setback from street but city said no. Applicant can move forward as of 6/10. Bottom floor may be leased by established furniture store. CPA firm will occupy the second story. She is looking into putting in her own parking. New Street Scape plan with Historic Review Board would add 14-16 more parking spaces.

Leslie Hayertz made the comment that ADA issues need to be addressed by the city before there are lawsuits.

Gail brought the meeting to order @ 7:01 p. m.

There was no meeting in January due to weather conditions (snow and ice)

We had a quorum of 8 people.

The application for the 2 story office building has been filed, but not yet gone to Planning Commission.

Noelle came to personally express gratitude from Main Street and Historic Willamette for the \$1000.00 funding for the solar lights and the wreaths. She expressed how people were impressed with the holiday décor. The comments she got from business owners and shoppers alike, was positive. Noelle in company went to city hall to start a conversation about streetscape design. (Lance was the only one to show up). She also informed us of a capital improvement project (and funding) for streetscapes. Lance (from the Planning Dept.), has plans for streetscape design. Lance showed them a streetscape with bicycle travel and historic nature of gardening .(Sounds much like the presentation Lance made to WNA last year regarding traffic on WFD and how to make it safer.) Bicycle lanes will remove many of the parking places along WFD. (Gail pointed out that other members of city government know nothing of this). Capital improvement project = funding bicycle lanes a must to receive funding. She asked us our input (questions to put on postcard to be sent out to all in WNA about said streetscape, concerns, safety, wants, improvements for Main Street). The survey is to be sent out in the next 6-8 weeks. District mailing. They will then host an Open House to show everyone what they came up with. They hope to have another meeting with Lance this spring. This will be a long term, multiple phase plan. Need to address parking. It is one of the top 3 things to be address.

Farmers Market = May 31st through Aug. 14th. It will along 14th Street. On the J Willeys side. Also will have use in front of the church.
