They are requesting to be rezoned low density residential. Brandon would purchase 3 lots on Brandon (yes same guy) Place and Dollar St. (What about PGE, TVFR, these things are not worked out yet.). What about the "walking path" (Tualitan River Greenway easement)? Brandon will do improvements on Dollar and Brandon Park. The old house will stay and is still occupied. He is not developing the back property, Tualitan River Greenway easement. Zoning would be R-10 (1 large lot divided into 3 R-10 parcels with one big lot behind. Would change zoning on all lots (entire property). Comprehensive Plan of Commercial not Neighborhood Commercial.

Brad = Main Street Historic introduced Rae Gordon to us. She is the new Main Street Manager. Noel is a volunteer now. Dec. 18<sup>th</sup> City Council meeting streetscape to be presented as per Transportation Plan.
