June 12, 2019 Willamette Neighborhood Draft Minutes

Julia brought the meeting to order at 7:00 p.m.

Treasurer = Elizabeth informed us that we have \$2970.24 in our account.

Minutes = the minutes were approved unanimously

John Williams (WL Community Development Director) informed us that all the electrical lines already above the ground, will stay above the ground, while the new street lighting (accommodate banners, holiday lighting, new streetlights, and the utilities (fiber-optics) will be placed under ground). City is working with Main St. to add electrical for special events. Outlets available at each street tree. Open House tomorrow from 6-8 p.m. Look at Financial Dashboard for Bond allocations.

TVFR = Cody Fordyce and Let. Todd Braeburn, Be careful with fire pits. They are to be only 3 ft. x 3ft. and flames are not to exceed 3 ft. in height. Thank you for voting to continuing the levy, it passed by 80%. It funds Water rescue (2 Newberg and 4 here). 3,500 people drown, nationally, every year (outside of boating). Life preservers are a must when around water. Those under 13 must wear preservers at all times, foam style (Coast guard certified). River currents are dangerous. www.boatus.org

Darren Wyss (WL City Planner) = Waterfront Project/Transportation Update. It has been a year since work was done on Waterfront Project due to Mill closure. City started this in 2016. Divided into 3 districts (Old City Hall, Industrial (PGE) and ponds). Open houses = 6/2017 Guided Principles, 9/2017(Solidify GP, how to improve Arch Bridge area, 4/2018 2 choices of community for traffic. Made final choice. PGE asked the city to step back. Mill closed, redesigned for safety and mobility. Redesigned for safety and mobility. City Council gave thumbs up on traffic pattern design. Zoning design over next 1 ½ years. 10ft. wide pedestrian/bike path trail. City is to put in dual lane roundabout. Bridge work is \$250 million (Abernathy Bridge widening) will take a couple years for girders and a couple more for the decking. Roundabout on the other side of freeway also city work. Lance Calvert said that tolls are 10-15 years away (Lance). On the exhibit green means landscape, dark gray= bikes, light gray = concrete. Existing Mill St. goes away. Use Territorial to get to Old City Hall. I-205 will concrete, not asphalt (lasts longer) due to studded tire use. Bus barn in purchased and a business is in it. PGE owns the composting site. Zoned industrial for all that is marked with red boundary.

Main St. = Wed. Market 4:00 – 8:00 p.m. Don't forget Street scape Open House tomorrow.

Kathie,

I shared today at our staff meeting with all of my sergeants and command staff, the concerns of the Fields Bridge parking and use. I also spoke with Code Enforcement and with the West Linn Parks Director. We will enforce all parking violations the law allows and keep an extra eye out for violations. Please be advised that the public right of way extends well off the roadway and if vehicles are not on or over the fog line, they may be legally parked. If they are legally parked, we as a law enforcement agency cannot cite or tow. We are aware of the issue and congestion. Not enough parking exists for the amount of usage the parks receive this time of year. The Parks Department is going to work with league organizers and attempt to separate game start times to avoid overlaps as much as possible and look to not allow games at Willamette Park EVERY weekend in an attempt to assist. Eventually, a middle school will be built across the street, providing additional parking relief during this season of the year. I have lived in West Linn for 26 years and have seen firsthand the volume of traffic that surrounds these events and the congestion it can create. There are no easy answers, but at least we can fully enforce the laws that exist and we will do so. If you have additional questions, feel free to call me (503) 655-6214.
