No Tolling presentation

Dean Suhr presented his petition to bring tolling on I 205 to a vote. He needs 200,000 signatures to put this issue on the ballot by June of 2024 citing the need to establish voter participation in this use of state highways. In 2017, the legislature passed HB17 to study tolling on all major highways. He said the revenue from toll fees is not tagged for maintenance and the laws do not include a sunset provision. ODOT needs to be transparent as to the uses of the revenue. He has petitions for those willing to pass them around.

Elizabeth read a letter outlining traffic and development concerns in Willamette that have not included residents concerns. She will speak to City Council and Planning Commission asking for time on the agenda for a discussion with affected residents. The letter will be amended before presentation.
